Academic Year 2009-2010**

During the 4-year term of Professor Olga Pugliese as Director of the Centre for Reformation and Renaissance Studies, the CRRS maintained its excellent reputation and developed and expanded its activities in several areas, notably in the undergraduate program in Renaissance Studies, in increased numbers of well-reviewed publications, and in annual conferences attracting participants from around the world and attended by many University of Toronto graduate and undergraduate students. Professor Pugliese maintained strong links with the broader community, including the Italian Cultural Institute and the Bata Shoe Museum. The Report of the CRRS External Review at the end of her mandate confirmed that under her guidance the Centre continued to excel. In 2009-2010 the number and quality of activities has remained high, the undergraduate program in Renaissance Studies continues to prosper, and the library has grown thanks to generous gifts and careful purchases. During this past academic year, the Centre participated in the planning exercise mandated by the Dean of the Faculty of Arts, and again received a very positive assessment and an encouragement to continue and to expand its activities.

There were some forty-five events for the year, ranging from intimate Friday seminar discussions of current research, focussed workshops and concerts, to major lectures and international conferences. They were attended by more than 1,800 participants. The Renaissance Spring Festival, sponsored by Victoria College and ably organized by Dr. Manuela Scarci, took place during the months of May and June 2009. Well-attended concerts held at the Four Seasons Centre for the Performing Arts were again a highlight, along with lectures, a dance workshop, and four Renaissance-related undergraduate courses. In June 2009, the CRRS collaborated with Emmanuel College and Knox College to sponsor a conference, *Rediscovering Calvin: Resources for Renewal Today*, an innovative venture which brought together scholars, ministers and laypeople to discuss Calvin's work and its impact. The CRRS was responsible for the historical stream of the conference, *Instituting Calvin: Society, Culture, and Diaspora Interdisciplinary Perspectives on Five Hundred Years of Global Calvinism(s)*. Shared plenary sessions were particularly successful.

In October 2009, the Centre hosted the annual Erasmus Lecture, given by Professor George Bernard of the University of Southampton on the topic: *The King's Painter: Holbein the Erasmian*. In the same month, a SSHRC-funded international conference, *To Have and to Hold: Marriage in Premodern Europe (1200-1700)*, was organized by the CRRS. In February 2010, we welcomed the annual CRRS Distinguished Visiting Scholar, Professor Patricia Demers of the University of Alberta, who gave two lectures, *Found in Translation* and *Renaissance Firsts*, and in addition met with colleagues and students interested in her work on early modern English women writers. In May, the CRRS sponsored the Sixth Annual Canada Milton Seminar, with keynote speakers from Yale, Exeter, and McGill Universities. At the end of May, the CRRS co-sponsored a session of the Symposium on *Drama and Religion 1555-1575*, which accompanied the mounting of the *Chester Cycle of Mystery* plays at Victoria College.

The undergraduate Renaissance Studies Program maintains healthy enrolments. An impressive poster for it was created over the summer of 2009 and distributed across campus. In the past year, the Renaissance Students' Association achieved status as a recognized campus organization, which allows it access to funding from the University of Toronto Arts and Science Student Union to sponsor both academic and social events. The first two Renaissance Students Association lectures were offered in 2009-10 by two of the Instructors in the Program, Steven Stowell and Brendan Cook.

Through important donations and judicious purchases of rare and modern works, including three 16th-century editions of works related to Erasmus, the library has continued to expand its holdings. Library usage continues strong, and thirty-two fellows, some local and others from approximately fifteen different universities, pursued research at the CRRS during the past year.

In addition to the journals *Renaissance and Reformation/Renaissance et Réforme*, *Early Theatre*, and *Confraternitas*, CRRS published two books in the Essays and Studies Series and a 3rd edition of a work in the Texts in Translation series. The Centre celebrated the publication of the first three works in the new series *The Other Voice in Early Modern Europe: The Toronto Series*. The first work in the CRRS series, the *Journey of Five Capuchin Nuns*, edited and translated by Sarah E. Owens was awarded the *Society for the Study of Early Modern Women's Josephine Roberts Prize for a Scholarly Edition*. CRRS Publications is branching out into electronic publication with the series Essays and Studies and *The Other Voice*. Online editions of these works are due for release in early 2011.

The CRRS is grateful for support received from academic and administrative units on campus, from external granting bodies, from community organizations, and from individual donors, in support of the programs, fellowships, library, publications, and other activities of the CRRS. Collaboration with the ITER project has continued to make it possible for the Centre to support a number of graduate students, in addition to those hired directly. During the past academic year, CRRS received and administered a total of \$239,636 in external donations and grants. The support of Victoria University's President Gooch, of Victoria College's Principal Cook and his Associate Director, and of the Chief Librarian and his staff is indispensable and much appreciated.

The CRRS depends on the energies and wisdom of the sixty or more faculty members from at least twenty five academic units who chair and serve on its committees. The CRRS is also supported by undergraduate and graduate research assistants who facilitate the work of scholars in the library and participate in the Iter project, by faculty teaching in the undergraduate courses and by part-time staff who look after publications, finances, and editorial work. In all its activities, the CRRS is ably served by the Assistant to the Director, Dr. Stephanie Treloar, who brings a strong academic background along with remarkable patience and organizational skills to her position.

I have very much enjoyed the opportunity to serve as Interim Director of the CRRS in 2009-2010. I would like to offer particular thanks to the members of the 2009-10 Executive Committee, and to Dr. Treloar. My very best wishes go to Professor Lynne Magnusson, whose term as CRRS Director is off to an excellent start.
